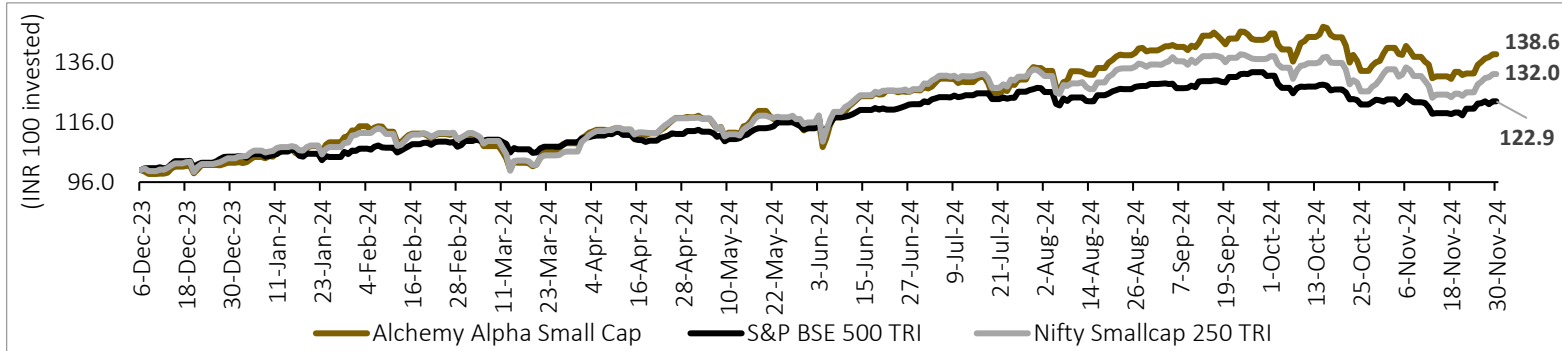

## NAV-Based Performance<sup>#</sup>



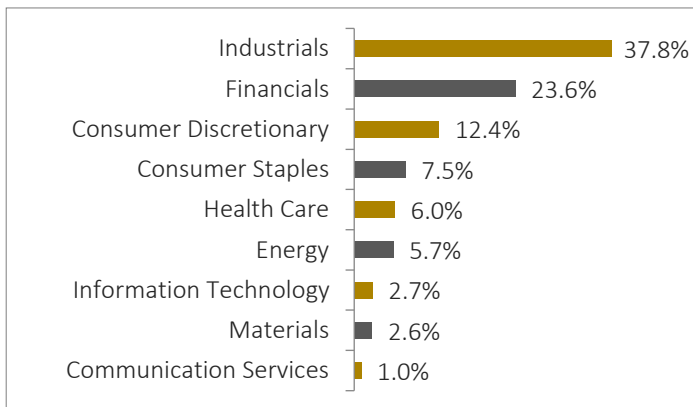

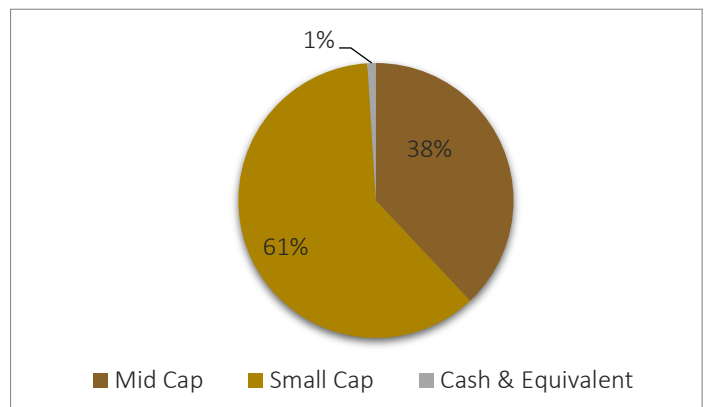
